We have to know what our fund value is at all times, and we also have to be able to calculate the risk we're taking. We build the models in front office, and send them off for use by the other teams in the organization.

We use F3 to calculate daily valuations and all of the risk for fixed income products such as interest rate swaps, swaptions, and bonds. We also deal frequently in currency, equities, inflation, and credit. F3's risk capabilities are very good, which we use to calculate portfolio risk and sometimes intra-day risk.
